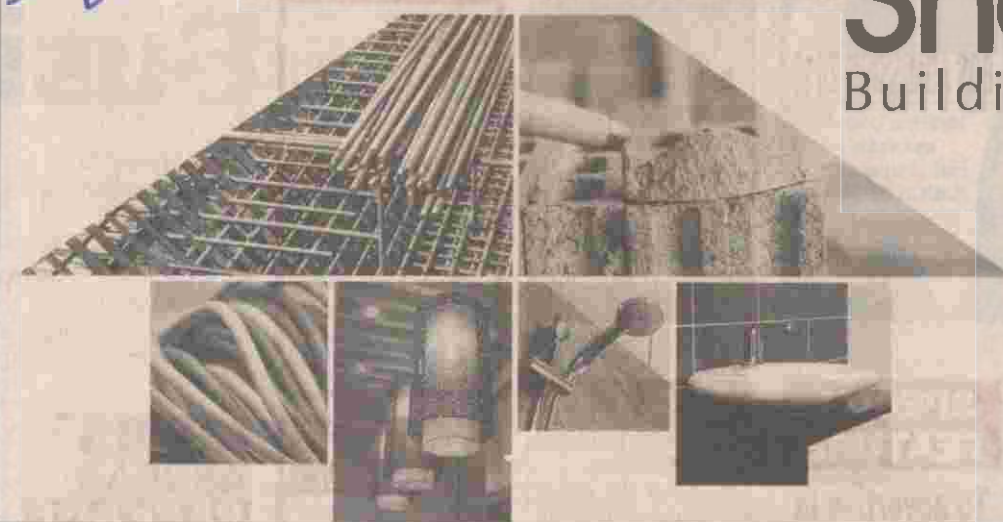
Motherson Sumi Consolidated Net Profit Declines 42%

New Delhi: Auto components maker Motherson Sumi Systems posted a 42% drop in consolidated net profit to ₹360.6 crore for the June quarter due to ramp-up of operations in two greenfield manufacturing units and tough market conditions. Net profit attributable to owners declined at a slower pace, by 25%, to ₹331.6 crore. Total revenue from operations went up 14% during the quarter to ₹16,792.6 crore. —Our Bureau

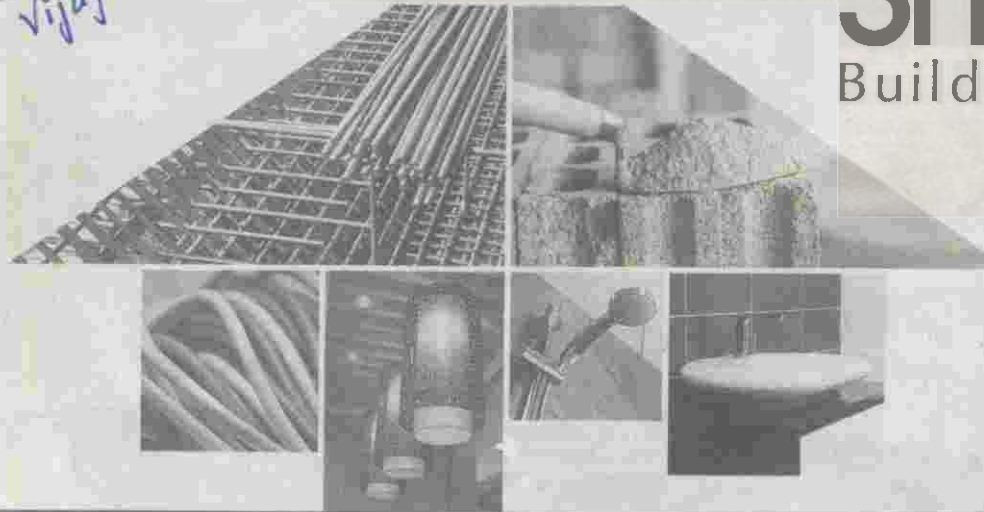
