Artificial Intelligence (AI) are set to become the bedrocks of communications infrastructure, with both having the potential to grow manifold in the coming years, Akash Ambani, director at Reliance Jio Infocomm, said on Friday.



"India's public cloud market is estimated to be \$2.6 billion in 2018, and over \$4 billion by 2020," Ambani said at the India Digital Open Summit in Mumbai. Research firm Gartner Inc had estimated the public cloud services market in India at \$1.81 billion in 2017.

Public cloud uses cloud computing technologies to support customers that are external to the provider's organisation. Using public cloud services generates the types of economies of scale and sharing of resources that can reduce costs and increase choices of technologies, Gartner said.

Making his first solo appearance at a public event, Akash, the elder son of billion-

naire Mukesh Ambani, also spoke about open source, blockchain and OpenStack.

Ambani said open source was very important for Jio, which is participating in many projects including ONAP. The Open Network Automation Platform (ONAP) is an open source networking automation standard.

Stating that the Open Source community helps drive the technology progression for areas of interest globally, Ambani said AI is becoming mainstream for all.

AI projects have leveraged Open Source to enable continuous innovation, he said, adding that along with broadband, one of the key technology enabling infrastruc-

ture. "In India, AR/VR is still in the initial stages of adoption, but market will register a compounded annual growth rate of more than 50% in the next five years," said Ambani. He said OpenStack - the world's largest fully open source cloud project - is being

Flipkart Can't Use 'MarQ' till Feb 5

New Delhi: A Delhi court has restrained Flipkart from using brand MarQ until February 5, dealing a blow to the e-commerce giant's large appliances private label. The interim judgement came after city-based appliances manufacturer Marc Enterprises alleged that Flipkart's brand was similar to its own and in violation of its trademark registered in 1984. "It seems that prima facie there is phonetic similarity between the trademark Marc of the plaintiff and trademark MarQ of the defendant," Justice Chandra Shekhar, additional district judge at Patiala House

Courts in New Delhi, said in his ruling on Thursday.

The "balance of convenience and irreparable loss" are in favour of the plaintiff and against the defendant,

Marc Enterprises alleged that Flipkart's brand was similar to its own and in violation of its trademark

the judge said, adding that Flipkart is restrained from using the MarQ brand for its products in any form and from any platform until the next hearing scheduled on February 5.

"Since the filed suit is sub judice, we do not wish to comment on the merits," a Flipkart spokesperson said.

Nipro's communications revenue dropped 0.7%. Unlike rivals TCS and Infosys, Nipro's banking and financial services revenue grew 4% sequentially in constant currency. The company's headcount dropped for the second consecutive quarter. It employed 1,62,553 people at the end of December, down from 1,63,759 at the end of September.

"We are driving non-linearity and driving automation as a company and as an industry there is some impact of that but very clearly I must share with you that we are going on campuses, we are hiring across the globe, there is significant gross hiring," Saurabh Govil, president at Wipro, said.

"While Wipro has been improving its operating performance, its topline growth has been muted," said Angel Broking's Nangra.
